Privacy Policy & Terms

We care about protecting the personal information of our visitors who use our website. This privacy policy provides details about how your personal information is collected, shared and used.

Collection and use of personal information

We do not collect any personal data about you on this web, apart from information which you volunteer share by using our online contact form or by e-mail. Any information which you provide in this way is NOT made available to any third party and is used only for the purpose for which you provided it. Cookies: Collection and use of technical information

The technical information will be used only by us and only for statistical and other administrative purposes.
